Community Schools United is a United Way strategy bringing resources and support directly to students, parents, and educators. They have engaged 19 partners, provided 1358 books, distributed 706 pieces of underwear, shared 942 backpacks, and much more.

Boys & Girls Clubs offers after-school and summer programming to youth of Phenix City/Russell County providing a positive, safe environment for our children.



The Ferst Readers program mails books monthly to registered children, birth to 5 focusing on low-income families to build their home libraries.

Girl Scouts provides the Girl Scout Leadership Experience (GSLE) to girls from kindergarten to 12th grade. Participation options are designed for girls whose families face economic challenges.

Big Brothers Big Sisters

offers a variety of programs designed to match children with caring adults to guide them on a path to success.



Boy Scouts has a new scout group for youth residents of Phenix City Housing Authority to deliver weekly programs.

Easterseals offers therapeutic care and education programs for both children and adults.

YMCA provides many opportunities to build a healthy spirit, mind, and body. Some of the services available are camps, sports, and swim lessons.

The Family Center empowers children and families of Phenix City/Russell County through counseling, mentoring, and other youth and family programs designed to promote healing, financial wellness, healthy development, and success in school, at home, and in the community.

Open Door offers a program for children focused on reading development and a program providing transitional housing for unaccompanied women experiencing homelessness.

The Salvation Army serves the Phenix City/ Russel County area through programs like Pathway of Hope, Alabama Project Share-Utilities Assistance, and EFSP-Utilities Assistance.

Hope Harbour provides
emergency shelter, advocacy,
and support services for
victims of domestic violence and their
children. The services provided in Russell
County give victims the opportunity to leave
a violent situation and become self-sufficient.

SafeHouse Ministries works closely with our neighbors experiencing homelessness. SafeHouse Ministries provides meals, clothing, case management, shelter and free substance abuse treatment.

House of TIME offers several programs and services geared toward healing, counseling, education, substance abuse treatment and improving life skills.



2-1-1 of United Way assisted 1,900 people from Alabama in accessing 2,800 referrals in the past year.

Feeding the Valley serves all of Russell County and provided enough food to serve 1,029,596 meals over the last year. In addition, they have a monthly Mobile Pantry that feeds 750 families.

American Red Cross

programs are available to Russell County residents, including emergency response, preparedness programs such as installation of free smoke alarms, and educational programs for youth.
